

**RECORD OF PROCEEDINGS**

Meeting of the Evansville Town Council, Evansville, Wyoming

August 28, 2017

The regular meeting of the Evansville Town Council of the Town of Evansville, County of Natrona, State of Wyoming, was held at 7:00 p.m. in the Council Chambers of the Town Hall.

The meeting was called to order by Mayor Pro-Tem Ernie Blackford at 7:00 p.m. and upon roll call the following were present: Mayor Pro-Tem Ernie Blackford, Council Members Joseph Knop, Jennifer Sorenson and Jory Delinger, Town Attorney Phil Willoughby, Town Treasurer Lexi Erickson, Chief of Police Tom Laughrey, Fire Chief Leo Malsom, Public Works Director Dan Adcock, Town Clerk Janelle Underwood, and interested citizens.

APPROVAL OF AGENDA: Motion was made by Joseph Knop and seconded by Jennifer Sorenson to approve the agenda. Motion carried.

APPROVAL OF MINUTES: The minutes for the regular meeting on August 14, 2017, and the Executive Session on August 14, 2017, were presented for approval. Motion was made by Jennifer Sorenson and seconded by Jory Delinger to approve the minutes as written. Motion carried.

APPROVAL OF DAY CARE LICENSE: Day Care License application for Oakwood Farms Day Care was presented to the Governing Body for approval.
